Major Duties & Responsibilities

Support

- foster youth, including participation in districtwide foster youth events.
- students identified as homeless.
- students with chronic or severe personal/social concerns that pose a high risk to the health or safety of the student or others through individual and group counseling sessions.
- students and families on SARB contracts, monitoring progress.
- Alternative Placement Students on formal district contracts with individual/group counseling, compile petition packets, provide referrals, as well as consult with parents, present cases to district office and monitoring students upon return to their home school.
- counseling staff in their efforts to reduce conflict and at-risk behavior for students identified as highly at risk.
- students at high risk due to severe mental health or behavioral incidents,

Implement

- comprehensive intervention programs as necessary.

Facilitate

- classroom presentations related to suicide awareness and teen safety .
- classroom presentations on bullying to 9th grade students in accordance with the district's zero tolerance.
- other presentations as developed by the intervention counselors for the district as the need arises.
- individual and group counseling

Communicate

- student's status/progress to appropriate school personnel and other adults responsible for the welfare of the student within the guidelines of confidentiality.

Liaise

- with community agencies that may be involved with students with chronic or severe emotional/behavioral issues that create a concern on campus for the safety of students and staff.

Collaborate

- with school administration and the school resource officer regarding identification and intervention for students identified as high-risk due to severe behavioral and/or mental health issues that affect overall school performance.

Develop and maintain

- professional working relationships with local and national community agencies in an effort to provide the best student care possible.

Serve

- as consultant for counselors, administrators, school psychologist and school nurse in conducting emergency student assessments (i.e. suicide, danger to others, and welfare check.)
- on District and community committees

Attend

- SST's and I.E.P meetings to support students on Intervention case-load.
- professional workshops and conferences to maintain professional growth by staying current with the latest trends and research in the counseling field.

Assist

- successful transition of both 9th grade and new students into high school that have been identified as highly at-risk for chronic or severe emotional/behavioral issues.
- parents in identifying support systems and/or programs.
